1. This competition **must** be held in strict accordance with the current *ISI Handbook*. **Any deviation from these manuals will void your approved endorsement.**
2. Each participant in this event must be a current member of ISI with all relevant tests registered with the ISI office.
3. The proposed event must comply with the requirements of the revised ISI/PSA/USFSA Joint Statement of Cooperation effective September 1, 2004.
4. For Inter-Rink and District competitions, a copy of this application **must** be submitted to and signed by your District Director. Competition dates require prior approval by the ISI District Director. **A copy of your skater/event schedule is due to the ISI office 2 weeks prior to the event for membership and test verification.**
5. The event host is a current ISI Administrative Member with dues and accounts paid up through the requested event date.
6. ***For Inter-Rink Competitions the host must have been an ISI Administrative Member for at least one year prior to the requested event date and have used the ISI Recreational Skating program and registered tests for the past year.***
7. The Competition Director must advise the ISI office at least 15 days prior to the proposed event of any known participants who are USFSA members that have competed at the Novice or above level at USFSA National Championships within the last two years.
